II. General information about data processing

1. Scope of the processing of personal data

Our processing of the personal data of our users is restricted to the data that are necessary for providing a functional website as well as our content and services. The personal data of our users are processed only for the purposes agreed with you or if there is any other legal basis (within the meaning of the GDPR). We only collect such personal data as are actually necessary for implementing and processing our duties and services, or that you have voluntarily provided to us.

2. Your rights (rights of the data subject)

You have the right to request information about the personal data concerning you that we have processed. In particular, you can request information about the purposes of processing, the categories of personal data, the categories of recipients to which your data have been or will be disclosed, the planned storage period, the existence of a right to rectification, erasure, restriction of processing or objection, data transmission (insofar as in the case of data

transmission this will not cause disproportionate effort), the origin of your data, insofar as these were not collected by us, and of the existence of automated decision-making, including profiling.

You also have the right at any time to withdraw any consent you have issued to the use of your personal data.

If you believe that our processing of your personal data contravenes the applicable data protection provisions, you have the option of complaining to the data protection body.

III. Description and scope of the data processing

1. Provision of the website

Use of Google Analytics as a web analysis service

Our website uses Google Analytics, a web analytics service provided by Google Inc., 1600 Amphitheatre Parkway, Mountain View, CA 94.043 USA, to evaluate the use of the website. Google Analytics uses cookies (see Point 2.) that are stored on your computer. The information these contain about the visitor's use of the website and the Internet can be processed and evaluated by Google.

The data collected by Google can be transmitted by Google to countries outside the EU and the EEA, especially the USA. However, Google has self-certified to the Privacy Shield Framework. Further information about your rights from this can be found at http://ec.europa.eu/justice/data-protection/document/citizens-guide_en.pdf.

In addition, we ensure that your IP address is anonymised before being transmitted to Google.

The legal basis for the use of Google Analytics is Article 6 Para. 1 (f) GDPR.

2. Cookies

We use cookies on our website to make our offering user-friendly. Cookies are small files that are automatically produced by your browser and stored on your end device (laptop, tablet, smartphone etc.) when you visit our website. The cookies continue to be stored until you delete them, and thus enable us to recognise your browser on your next visit.

Should you not want this, you can set your browser so that it informs you of the placement of cookies and you can allow this on a case-by-case basis. However, we wish to point out that disabling cookies will result in your being unable to use all the functions of our website.

The legal basis for the data processed by cookies is Article 6 Para. 1 (f) GDPR.

The "langactive" cookies, which store the selected language, are deleted at the end of the browser session.

3. Contact form

If you fill in a contact form or send us an email or other electronic message, your data will only be stored for processing your enquiry and for possible further questions associated with this, and will only be used in the context of your enquiry.

The legal basis for processing your enquiry is Article 6 Para. 1 (b) GDPR.

4. Newsletter

If you enter your email address and first and last names, and transmit these details to us, you are giving your consent to store these details (including the date of your registration) on our systems, in accordance with Article 6 Para. 1 (a) GDPR. We will only use these details for administering and sending out the newsletter.

The newsletter contains information on how you can unsubscribe from the newsletter again. If you unsubscribe from a newsletter, the status of your email address in the distribution list of the newsletter concerned will be changed to "deactivated". If you are no longer registered for the newsletter, your email address will be completely deleted from the newsletter system together with the other details you provided.

Our newsletter contains no obvious or concealed counters, third-party advertising or links to third-party sites that are not directly connected with the content of our newsletter.

5. File downloads

We do not request any personal details from you in order for you to be able to download files from our website.

6. Social plugins

All the incorporated social plugins work via the 2-click process; in other words a plugin only starts recording your surfing behaviour once you activate the corresponding plugin in the first place by clicking on it. If, at the same time as visiting our website, you are also logged in to your Facebook account, for example, Facebook will register your visit to our website after the plugin is activated (first click) and can then allocate this visit to your user account.

IV. Data security

During your visit to the website, we use the SSL procedure in combination with the respective highest level of encryption supported by your browser. You can tell by the closed lock symbol
